The Libyan Ports and Maritime Transport Authority will introduce a new system for publishing maritime circulars and notices to facilitate research as well as to report any issue that needs to be addressed.

SHIPPING MARINE CIRCULARS (SMC).

These used to communicate the standards of instructions, orders, directive, and notices issued by the maritime authority represented by the Libyan Ports and Maritime Transport Authority including technical and operational requirements under the legal interpretation of the Libyan flag and the provisions of the international standards of the International Maritime Organization.

And they are directed to ship owners and operators, shipping agents, ship masters and recognized organizations and they must abide by what is stated in the circular.

MARINE NOTICES CIRCULARS. (MN).

These notices used to communicate useful information in the field of commercial maritime transport. These notices are for informational purposes only and for example to inform (shipowners, operators, shipping agents, masters and recognized organizations) about the issuance of an amendment or maritime agreement that will come into force.
